2. ALL TRAINEES must sign in when you arrive at each training session.

3. THE TRAINEE is expected to arrive at training ½ hour before class starts to participate in the warm up and exercise program. This is a required part of the training program.

4. KnokX Pro T-Shirt required for all THE TRAINEES to wear while training.

5. ALL TRAINEES must wear wrestling boots, elbow pads, and knee pads.

6. The gym is your domain and you will respect the entire premises as such. The following are the ring rules THE TRAINEE will be responsible for:
